Thank you for your interest in working at Chatham Marketplace (CM). We are a cooperatively owned grocery store, operated for the benefit of our community owners. A cooperative is an independent group of people joining freely to meet their common economic, social and cultural needs through a democratically governed business. Cooperatives are guided by seven principles which are; voluntary participation, democratic control, economic participation, independence, education, cooperation among cooperatives and concern for community. In the tradition of their founders, cooperative members believe in the ethical values of honesty, openness, social responsibility, and caring for others.

Chatham Marketplace is owned entirely by local people; therefore, the market's success is linked to the economic well-being of the county and its citizens. Recognizing its dependency on the health of the community, Chatham Marketplace buys and sells local products, and Chatham Marketplace provides meaningful, good-paying jobs to local residents. CM provides the most complete shopping option for people in Chatham County interested in pursuing a healthy lifestyle and conscious of where their dollars are being spent.

The main duty of all CM employees is exemplary customer service to all. Employees are expected to be friendly, knowledgeable, and responsible and be willing to take the initiative to make each shopper's experience extraordinary.

By accepting a position at CM you are agreeing to abide by the personnel policies and expected to work your assigned shifts. As a co-op employee, you will be expected to work a minimum of 20 hours per week. Our hours are Monday through Sunday 7 am to 9 pm. We are open everyday except Christmas Day. The holiday season (November 15<sup>th</sup> - December 31<sup>st</sup>) is our busiest season, please be aware that you may be expected to work more shifts than normal during this time, and should not request vacations during this busy time. Several times a year we hold Owner Appreciation Days or other special events, during which all employees may be expected to work. Several times a year we hold staff meetings, which are mandatory for all employees to attend.
